Institutional Characteristics Overview

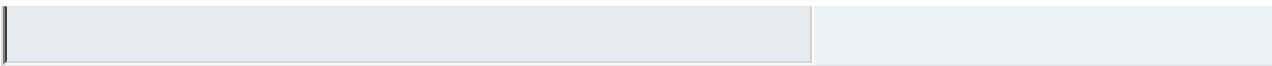
